EOSC portal: EOSChub, OpenAIRE, and others – November (s), for training we need help, publish a list of recommendated links to learning resources

Relevant Training and skills recommendations EOSCpilot / FAIR WG

Skills framework FAIR4S, training is one route to acquire skills (mentorship, selfpaced learning), definitions from the framework e.g. stewardship, apply it, avoid duplication of effort put in useful resources, works put forward

Digital skills working group, skills gap, zetoro references list, case studies

 Current activities of the Community of Practice of training coordinators and link to EOSC training.

What training and guidance resources are needed at the EOSC level?

Where should they be most effectively located to get noticed and used?

- Institutional level, e.g. through RDM services
- National level, e.g. through national service providers
- Discipline level, e.g. through Research Infrastructures, EOSC cluster projects, etc.
- Cross-domain level, e.g. through horizontal EOSC services
- Thematically, e.g. through stakeholders addressing specific challenges

How can training and guidance resources, i.e. materials and event information, be pooled effectively across the EOSC, e.g.

- By manually selecting and curating training and guidance resources?
- By aggregating training automatically from selected providers?
- By aggregating training portals?
- By identifying people able to respond to discipline-specific questions from researchers about making data FAIR?

Sharing Training materials and events – block 1

How is your training content "packaged" and made available, discoverable and interoperable?

 TeSS/ELIXIR: aggregating semi-automatically using bioschemas as metadata

Aggregator. Includes resources, events, carpentries. Google finds as well as TeSS

 Essentials 4 data support (RDNL), MOOC: RDNL/DCC, platform FutureLearn, more than 1000 particpants

Alternative to Fruitful, Advantageous Interesting, Relevant

• Github/Library Carpentry:

Building data skills, collaboratively developed lesson materials, curriculum, volunteering instructors/trainers,

Competency model, competency development programs, RDM elearning modules
